Prior to 12 October 2018, Aqua Wealth Holdings Limited ("Aqua Wealth") holds 332,057,772 units in the Trust. DBS Trustee Limited holds the entire issued share capital of Aqua Wealth as the trustee of a family trust (the "Zhang Family Trust"). The power to make investment decisions on behalf of the Zhang Family Trust is conferred solely on an investment committee, of which Zhang Zhencheng is the sole member. Therefore, Zhang Zhencheng is deemed to be interested in Aqua Wealth's direct interest in units of the Trust. On 12 October 2018, Aqua Wealth acquired 3,500,000 units in the Trust via market transaction. With the transaction, Aqua Wealth's units in the Trust increased to 335,557,772.

Bounty Way Investments Limited ("Bounty Way") holds 28,208,759 units of the Trust. Zhang Zhencheng owns 100% of the equity interest in Bounty Way. Therefore, Zhang Zhencheng is deemed to be interested in Bounty Way's direct interest in the Trust.

Dasin Retail Trust Management Pte. Ltd. ("DRTM") holds 3,788,976 units in the Trust. Zhang Zhencheng owns 99% of the equity interest in DRTM. Therefore, Zhang Zhencheng is deemed to be interested in DRTM's direct interest in the Trust.
