Aqua Wealth Holdings Limited ("Aqua Wealth") holds 335,557,772 units in the Trust. DBS Trustee Limited holds the entire issued share capital of Aqua Wealth as the trustee of a family trust (the "Zhang Family Trust"). The power to make investment decisions on behalf of the Zhang Family Trust is conferred solely on an investment committee, of which Zhang Zhencheng is the sole member. Therefore, Zhang Zhencheng is deemed to be interested in Aqua Wealth's direct interest in units of the Trust.

Bounty Way Investments Limited ("Bounty Way") holds 28,208,759 units of the Trust. Zhang Zhencheng owns 100% of the equity interest in Bounty Way. Therefore, Zhang Zhencheng is deemed to be interested in Bounty Way's direct interest in the Trust.

Prior to 20 March 2019, Dasin Retail Trust Management Pte Ltd ("DRTM") held 6,299,775 units in the Trust. Zhang Zhencheng owns 99% of the equity interest in DRTM. Therefore, Zhang Zhencheng is deemed to be interested in DRTM's direct interest in the Trust.

On 20 March 2019, Aqua Wealth acquired 1,200,000 units in the Trust from DRTM via an off-market transaction (married deal). With the transaction, Aqua Wealth's units in the Trust increased to 336,757,772 and DRTM's direct interest in the Trust decreased to 5,099,775.

There is no change in Zhang Zhencheng's direct or deemed interest in the Trust arising from this transaction, since the increase in his deemed interest in the Trust via Aqua Wealth is offset by the corresponding decrease in his deemed interest in the Trust via DRTM.
