On 11 August 2021, Harvest Private Wealth Income Fund 4 SP ("HPWIF4") disposed 1,300,000 units in the Trust via an off-market transaction (married deal). With the transaction on 11 August 2021 and together with a series of market transactions prior to 11 August 2021 totalling a net increase of 630,000 units in the Trust, HPWIF4's direct interest in the Trust decreased from 5.03% to 4.87%.
