As announced on 6 May 2021, Aqua Wealth Holdings Limited ("Aqua Wealth") has a share pledge arrangement on its units in Dasin Retail Trust with CGS-CIMB Securities (Singapore) Pte. Ltd. ("CGS-CIMB") in relation to certain share margin financing facilities granted by CGS-CIMB to Aqua Wealth. Pursuant to the share margin financing facilities, CGS-CIMB had exercised its margin call on a total units of 140,700 on 27 August 2021.

DBS Trustee Limited ("DBS Trustee") holds the entire issued share capital of Aqua Wealth Holdings Limited ("Aqua Wealth") as the trustee of a family trust that is known as the Zhang Family Settlement (the "Zhang Family Trust"), of which Mr. Zhang Zhencheng is the settlor and the beneficiaries of the Zhang Family Trust are:-

- 1) Zhang Chon Meng, son of Zhang Zhencheng;
- 2) Zhang Guiming, nephew of Zhang Zhencheng;
- 3) Zhang Kunming, nephew of Zhang Zhencheng;
- 4) Zhang Shenming, nephew of Zhang Zhencheng; and
- 5) Liang Jinying, sister-in-law of Zhang Zhencheng.

The power to make investment decisions on behalf of the Zhang Family Trust is conferred solely on an investment committee, of which Mr. Zhang Zhencheng is the sole member. Aqua Wealth holds 361,946,504 units in the Trust. Therefore, Mr. Zhang Zhencheng is deemed to be interested in the units held by Aqua Wealth.

Bounty Way Investments Limited ("Bounty Way") holds 28,208,759 units of the Trust. Mr. Zhang Zhencheng owns 100% of the equity interest in Bounty Way. Therefore, Mr. Zhang Zhencheng is deemed to be interested in the units held by Bounty Way.

Dasin Retail Trust Management Pte. Ltd. ("DRTM") holds 28,022,570 units in the Trust. Mr. Zhang Zhencheng owns 99% of the equity interest in DRTM. Therefore, Mr. Zhang Zhencheng is deemed to be interested in the units held by DRTM.

Mr. Zhang Zhencheng owns 99% of the equity interest in the Trustee-Manager. The remaining 1% interest of the Trustee-Manager is owned by Shun Feng Investments Limited, where Mr. Zhang Zhencheng is the sole shareholder. Accordingly, Mr. Zhang Zhencheng is deemed to be interested in the units held by the Trustee-Manager.

The percentage of unitholdings immediately before and after this transaction is calculated on the basis of 784,694,901 outstanding units.
