**HC/OA 68/2026 (“OA 68”)**  
**MALAYAN BANKING BERHAD, SINGAPORE BRANCH v. DASIN RETAIL TRUST**  
**MANAGEMENT PTE. LTD.**

1. We act for Malayan Banking Berhad, Singapore Branch, the Applicant in OA 68. We refer to our letters dated 15 January 2026, 19 January 2026 and 20 January 2026 (“Letters”). Unless otherwise stated, we adopt the definitions used in the Letters therein.
2. An RCC in respect of OA 68 was held by virtual means on 21 January 2026, at 2.30pm. At the end of the RCC, the Learned Assistant Registrar Jacqueline Lee issued the following timelines and directions which are contained in paragraphs 3 to 5 of this letter.

3. In relation to the Company and/or its creditors:
  - (1) If the Company intends to appoint solicitors, the proposed solicitors of the Company shall file a Notice of Appointment of Solicitors to Court by 29 January 2026, 4pm.
  - (2) If the Company intends to have an officer of the Company represent itself, the officer of the Company shall file the necessary application to Court by 29 January 2026, 4pm.
  - (3) If any other creditor of the Company intends to appoint solicitors, the proposed solicitors of such creditor shall file a Notice of Appointment of Solicitors to Court by 29 January 2026, 4pm.
4. In relation to the IJM Application i.e. the Summons:
  - (1) The sealed Summons will be issued shortly and will be dated 16 January 2026.
  - (2) Any party who wishes to oppose the Summons shall file and serve its affidavit by 29 January 2026, 4pm.
  - (3) Any party who wishes to file an affidavit in reply to an affidavit filed in opposition shall file and serve its affidavit by 3 February 2026, 4pm.
  - (4) Written submissions and bundle of authorities to be filed and served (including hard copies to be tendered to Court) by 6 February 2026, 4pm.
  - (5) The hearing for the IJM Application is tentatively fixed for 13 February 2026. The date and time will be confirmed by the Court separately by way of Registrar's Notice, and the Applicant will notify the Company accordingly.
  - (6) The Applicant is to give notice of the Summons to all creditors known to the Applicant. In this regard, we hereby request that you, being the Company, give notice to each of the directors of the Company of the Summons filed (and make available to them copies of the relevant cause papers) insofar as they may have claims against the Company. We will send you a copy of the sealed Summons when it is issued by the Court.
  - (7) The Company is also to give notice of the Summons to all creditors known to the Company, and to make available copies of the cause papers filed in the Summons to them.
5. In relation to OA 68 i.e. the main JM Application:

- (1) Any party who wishes to oppose OA 68 shall file and serve its affidavit by 9 February 2026, 4pm.
- (2) Any party who wishes to file an affidavit in reply to an affidavit filed in opposition shall file and serve its affidavit by 23 February 2026, 4pm.
- (3) Written submissions and bundle of authorities to be filed and served to Court (including hard copies to be tendered to Court) by 2 March 2026, 4pm.
- (4) The hearing for the JM Application is tentatively fixed on 9 March 2026. The date will be confirmed by the Court separately by way of Registrar's Notice, and the Applicant will notify the Company accordingly.
- (5) The procedural timelines required for a judicial management application under the Insolvency, Restructuring & Dissolution Act 2018 and all subsidiary legislation therein (including but not limited to the requisite advertisements of the JM Application) shall apply as usual.
